Whereas, it has been deemed necessary to reestablish Megeleta Oromia News Paper;  
Now, therefore, in accordance to the Constitution of the Oromia National Regional State Proclamation Number 46/1993 Article 49(3) (a), it is hereby proclaimed as follows.

**1. Short Title**  
This proclamation may be cited as, "Reestablishment Proclamation of the Megeleta Oromia News Paper, Number 186/ 2014".

**2. Reestablishment of the Megeleta Oromia News Paper**  
Legal News Paper known as, "Megeleta Oromia" and published under the control of 'Caffee' Oromia is hereby reestablished by this proclamation.

**3. Dhimmoota Magalata Oromiyaa Irratti Maxxanfamanii fi Haalawwan Guutamuu Qaban**

1). Labsiin, Dambiin, Waliigalteen Mootummaa Naannichaatiin taasi-famuun Caffeedhaan ragga'anii fi Seerri Naannichaa kamiyyuu Magalata Oromiyaarratti maxxanfamanii ni bahu.

2). Qaamni Seera Tumaan, Seera Raawwachiiftuu fi Seera Hiiktuun, akkasumas namni uumamaa ykn seeraan qaamni seerummaa kenameef kamiyyuu seera Magalata Oromiyaa irratti maxxanfamanii bahan hojii irra oolchuf dirqama qaba.

3). Magalatni Oromiyaa kan maxxanfamu Afaan Oromoo, Amaariffaa fi Ingiliffaan ta'a. Afaanota sadeen gidduutti garaagarummaan qabiyyee yoo uumame kan Afaan Oromoo fudhata ma ni qabaata.

**4. Aangoo Magalata Oromiyaa Maxxansiisuu**

Caffeen Mootummaa Naannoo Oromiyaa hojii maxxansa Magalata Oromiyaa ni gurmeessa. Afaan Oromoo, Amaariffaa fi Ingiliffaan akka maxxanfamee bahu ni taasisa.

**5. Seera Haqame**

Labsiin Magalata Oromiyaa Dhaabuuf Bahe, Lak. 1/1985 Labsii kanaan haqamee jira.

**6. Yeroo Labsiin Kun Hojii irra Itti Oolu**

Labsiin kun Bitootessa 18 Bara 2006 irraa jalqabee hojii irra kan oolu ta'a.

፮) መገለጥ አሮሚያ የሚታተመው በአፋን አሮሞ፣ በአማርኛና በእንግሊዝኛ ይሆናል። በሶስቱ ቋንቋዎች መካከል የይዘት ልዩነት በሚፈጠርበት ጊዜ የአፋን አሮሞ ቅጂ ተቀባይነት ይኖረዋል።

፯. መገለጥ አሮሚያን የማሳተም ስልጣን ጨፌ አሮሚያ የመገለጥ አሮሚያ ጋዜጣ ህትመት ስራን ያደራጃል። በአፋን አሮሞ፣ በአማርኛና በእንግሊዝኛ ቋንቋዎች ታትሞ እንዲወጣ ያደርጋል።

**3. Matters to be Published on Megeleta Oromia and Conditions to be Fulfilled**

1) Proclamation, Regulations enacted, agreement entered by the Regional Government of Oromia and ratified by 'Caffee' and any law of the Region shall be published on Megeleta Oromia.

2) The Legislative, Executive and Judiciary body of Government and any natural or legal person shall have obligation to execute laws published on the Megeleta Oromia.

3) Megeleta Oromia shall be published with Afan Oromo, Amharic and English languages. Where difference in content arises between the three languages, version of Afan Oromo shall prevail.

**4. Power to Publish Megeleta Oromia**

'Caffee' Oromia shall organize publishing work of the Megeleta Oromia; And made facilitation to be published in Afan Oromo, Amharic and English languages.

**5. Repealed Law**

The Proclamation establishing Megeleta Oromia Number 1/1993 is hereby repealed by this Proclamation.

**6. Effective Date**

This Proclamation shall enter into force as of 27<sup>th</sup> day of March 2014.
