WHEREAS, it has been found necessary to empower and restructure the organization of the Judicial Administration Council in such a way that enables it to maintain the balanced independence and accountability of the state judiciary;

BELIEVING, that the delay in the investigation or adjudication of disciplinary complaints that has lowered public confidence in the courts and hindered the judicial community to take lessons from disciplinary measures taken promptly should be re-invigorated radically in such a way that an efficient, accessible and effective disciplinary process is in place;

WHEREAS, it has been found necessary to re-organize the work process of the Council with a view to bringing about radical improvement in the judicial administration of the region's courts;

NOW, THEREFORE, in accordance with Article 49 (3)(a) of the 2001 Revised Constitution of National Regional State of Oromia, it is hereby proclaimed as follows.

PART ONE

GENERAL PROVISIONS

1. Short Title

This proclamation may be cited as "the Proclamation to Provide for the Re-establishment of Oromia Judicial Administration Council Proclamation No.142/2008".

2. Definition

In this Proclamation unless the context demands otherwise:

- 1) "Caffee," shall mean the legislative organ of Oromia National Regional State.
- 2) "Supreme Commission," shall mean the Judicial Administration Commission of the region established at the Supreme Court of Oromia by this Proclamation.
- 3) "Adjudicatory Team," shall mean the organ of the Judicial Administration Commission established at the Supreme Court and the Zonal High Court in accordance with this Proclamation.

- 4) “Garee Inispeekshinii,” jechuun qaama Gumii Bulchiinsa Abbootii Seeraa Oromiyaa ta’ee sadarkaa Mana Murtii Waliigalaafi Mana Murtii Ol’aanaatti Labsii kanaan dhaabbateedha.
- 5) “Gaggeessaa Dhimma Naamusaa Aanaa,” jechuun Pirezidaantii Mana Murtii Aanaa jechuudha.
- 6) “Abbaa Seeraa,” jechuun akkaataa seeraatti Gumii Bulchiinsa Abbootii Seeraa Naanootiin filatamee Caffeedhaan kan muudameedha.
- 7) “Kaadhimamaa Abbaa Seeraa,” jechuun Gumii Bulchiinsa Abbootii Seeraatiin filatamee hanga Caffeedhaan muudamutti ogummaa seeraa irratti ramadame kan hojjetuudha.
- 8) “Muudamtoota Gumii,” jechuun itti gaafatamaa, inispeektara, ekspartii, ofiisara seeraa, gaggeessaa dhimmaa, abbaa adeemsa hojii, qaadii, abukaatoo ittisaafi kanneen biroo gumiidhaan muudamaniifi ramadaman ni dabalata.
- 9) “Hojjataa Deeggarsaa,” jechuun hojjataa Mana Murtii Oromiyaa bu’uura seera bulchiinsa hojjattoota mootummaa naannichaatiin qacarame jechuudha.

3. Daangaa Raawwatiinsa Labsii Kanaa

Labsiin kun kanneen armaan gadii irratti raawwatiinsa ni qabaata:

- 1) Abbootii seeraafi muudamtoota Gumii Manneen Murtii Oromiyaa keessa hojjataniifi himannaan naamusaa utuu isaan irra jiruu hojii kan gadi lakkisan.
- 2) Hojjattoota deeggarsaa ilaalchisee dhimma naamusa isaanii qorachuu, himachuufi murteessuuf akkaataa Labsii kana keessatti ibsameen Labsiin kun isaan irrattii raawwatiinsa ni qabaata.

4. Hundeeffama

Gumiin Bulchiinsa Abbootii Seeraa Oromiyaa (kanaan booda “gumii” jedhamee kan waamamu) haala haaraatiin Labsii kanaan dhaabbateera.

5. Gurmaawina Gumii

Gumiin qaamilee armaan gadii ni qabaata:

- ፰) “የጉባኤ ተሻሚዎች” ማለት ኃላፊ፣ ኢንስፔክተር፣ ኤክስፐርት፣ የሕግ አራሲር፣ የጉዳይ ኃላፊ፣ የሥራ ሂደት ኃላፊ፣ ቃዲ፣ ተከላካይ ጠበቃ እና ሌሎችንም በጉባኤው የተሾሙና የተመደቡትን ይጨምራል።
- ፱) “ድጋፍ ሰጪ ሠራተኛ” ማለት በክልሉ የሠራተኞች አስተዳደር ሕግ መሠረት ተቀጥሮ በኦሮሚያ ፍ/ቤት የሚሠራ ነው።

- 4) “Inspection Team,” shall mean the body established at the Supreme Court and Zonal High Courts to investigate disciplinary complaints made against the judicial community of the region’s courts in accordance with this Proclamation.
- 5) “District Courts Disciplinary Process Manager,” shall mean the President of a District Court
- 6) “Judge,” shall mean a person who, in accordance with the law, has been nominated by the Regional Judicial Administration Commission and appointed by the ‘Caffee’.
- 7) “Candidate Judge,” shall mean a person who, has been nominated by the Regional Judicial Administration Commission to work as a legal expert until appointed by the ‘Caffee’.
- 8) “Appointees of the Council,” shall mean head, inspector, expert, legal officer, case manager, process owner, Qadi, defense counsel and others appointed and assigned by the Regional Commission.
- 9) “Administrative Staff” shall mean any person employed as civil servant in the courts of the region in accordance with civil servants law of the region’s government.

3. Scope of Application

This proclamation shall be applicable on the following:-

- 1) Judges and Appointees of the Commission working in Oromia courts and on those released from the region’s courts while disciplinary suit made against them is pending.
- 2) The provisions of this Proclamation shall be applicable to the administrative staff of the region’s courts on matters related to investigating their discipline, charging and adjudication of disciplinary offenses committed by them.

PART TWO

Establishment and Organization Of Judicial Administration Commission of Oromia

4. Establishment

The Judicial Administration Commission of Oromia National Regional State hereinafter referred to as “the Commission” is hereby re-established by this Proclamation.

5. Organization of the Commission

The Commission shall have the following bodies:-
(a) Supreme Commission,

- (b) Garee Gumii Naannoofi Garee Inispeekshinii Naannoo,
- (c) Garee Gumii Godinaafi Garee Inispeekshinii Godinaa,
- (d) Waajjira Gumii.

PART THREE

Regional Commission, Regional Commission's Adjudicatory Team, Regional Inspection Team and Secretariat of the Commission

A. REGIONAL COMMISSION

6. Members of the Supreme Commission

- 1) The Supreme Commission shall have the following members:-
 - (a) President of the Supreme Court..... chairman;
 - (b) Vice President of the Supreme Court..... deputy chairman;
 - (c) From among members of the 'Caffee' those having awareness about the business of the judiciary or knowledge of law as appointed by the Speaker of 'Caffee'... two members,
 - (d) Two judges..... members, and,
 - (e) One Appointee of the Commission ... member.
- 2) The head of the Secretariat of the Commission shall serve as secretary of the Regional Commission without having vote.

7. Criteria for Membership and Procedure for Selection of Members of Supreme Commission From Among Judges and Appointees of the Commission

- 1) Any person shall become member of the Regional Commission where he has got proven integrity or high moral character and competence as well as possess requisite experience and knowledge with respect to administration of courts.
- 2) Based on the criteria indicated here-in-above the President of the Supreme Court shall select 4 candidates from among judges and two candidates from among Appointees of the Commission and forward this proposal for approval to the Conference of Judges and Appointees of the Commission.
- 3) This Conference of Judges and Appointees of the Commission shall elect two judges and one Appointee of the Commission for representation in the Regional Commission by majority vote.

- 3) Hanga Caffeedhaan muudamanitti, kaadhimamaa abbaa seeraa ta'anii ogeessota filataman hojii seeraarratti ramadee ni hojjachiisa;

- 2) Assign judges whose appointment is approved by the 'Caffee';
- 3) Assign and deploy candidate judges until they are appointed by the 'Caffee';
- 4) Appoint, regulate and dismiss Appointees of the Commission based on existing rules and regulations;
- 5) Terminate the tenure of those judges and Appointees of the Commission who demonstrate gross incompetence, inefficiency and unable to perform their judicial responsibilities on account of illness in accordance with the regulations on performance appraisal;
- 6) Issue regulations and directives on the performance appraisal and professional conduct of judges and Appointees of the Commission, complaint handling and investigation of disciplinary matters, meeting protocol and working procedures of the Regional Commission and Adjudicatory Teams of the Commission and code of conduct for members of the Regional Commission, Adjudicatory Teams and Inspectorate Teams of the Commission, as well as follow up implementation of same;
- 7) Issue regulations and directives relating to recruitment and selection, appointment, immunity, assignment, salary, allowances, medical benefits and insurance, promotion, training and education, holiday and annual leave, transfer, dismissal and other benefits of judges and Appointees of the Commission;
- 8) Issue directives with respect to the allowances of members of the Supreme Commission;
- 9) Decide on matters relating to increment of salary and different benefit packages as well as promotion of judges and Appointees of the Commission;

- 2) The plenum of the Supreme Court judges shall elect two from among those proposed for consideration.
- 3) The President shall assign one person as member of the Adjudicatory Team from among the appointees of the Council at the Supreme Court level based on the criteria established for this purpose.
- 4) The court supportive staffs assigned as members of the Adjudicatory Team shall be elected by the plenum of the Supreme Court administrative staff by majority vote whenever disciplinary issues pertaining to the administrative staff is involved.

12. Powers and Duties of the Regional Adjudicatory Team

The Regional Adjudicatory Team shall have the following powers and duties:-

- 1) Determine issues relating to simple disciplinary offenses committed by Judges and appointees of the Commission at the Supreme Court level;
- 2) Make decisions on issues relating to grave disciplinary offenses committed by the judicial community in the region's courts;
- 3) Review the decision of the head Regional Inspectorate Team whenever appeal is made to it on such decision and shall give the final decision;
- 4) Determine disciplinary issues relating to breach of disciplinary duties by the supportive staff of the Supreme Court in accordance with the pertinent civil service law.

13. Powers and Duties of the Chairperson of the Regional Adjudicatory Team

The chairperson of the Regional Adjudicatory Team shall have the following powers and duties:-

- 1) Prepare agenda of the meeting, convene the team's meeting and preside over it.
- 2) Coordinate the activities of the Adjudicatory Team;

15. Powers and Duties of the Regional Inspection Team

The Regional Inspection Team shall have the following powers and duties:-

- 1) Receive complaints and grievances made service delivery of the state courts;
- 2) Investigate the matter where it is convinced that there are evidences that show breach of disciplinary duties from examination of complaints and grievances.
- 3) Frame charge, prosecute and seek appeal as necessary upon being convinced that there is sufficient evidence for breach of ethical duties leading to prosecution;
- 4) Close the file and issue report on same to the chairman of the Supreme Commission where it is convinced that there is no sufficient evidence to prosecute for breach of ethical duties based on its assessment of the complaints or the results of its investigation;
- 5) Study the causes of ethical misconduct in the state judiciary and forward recommendations to the Supreme Council on how ethical standards could be improved;
- 6) Organize awareness raising programs that aims at creating judicial community that does not tolerate unethical behavior and follow up implementation of same;
- 7) Investigate and prosecute grave disciplinary offenses committed by the judicial community in the region's courts;
- 8) Conduct periodic assessment on the performance of Oromia courts with respect to judicial service and issue recommendations to the plenum of the different bodies of the Judicial Administration Council as to how the problems detected could be alleviated;

17. Organization of the Secretariat

The Secretariat of the Judicial Administration Commission shall have a head, experts and supportive staffs necessary to discharge its functions properly.

18. Powers and Duties of the Secretariat

The Secretariat shall have the following powers and duties:-

- 1) Enforce the decisions of the Commission;
- 2) Facilitate working conditions for the Council, Adjudicatory and Inspection Teams of the Commission and see to it that their files and documents are organized properly;
- 3) Provide the necessary technical assistance for Zonal Adjudicatory and Inspection Teams;
- 4) Receive grievances or complaints pertaining to administrative issues;
- 5) Collect and organize information with respect to the performance of the various bodies of the Commission and disseminate same to concerned bodies.

19. Powers and Duties of the Head of the Secretariat

The head of the Secretariat shall have the following powers and duties:-

- 1) Direct and supervise the activities of the Secretariat;

22. Powers and Duties of the Zonal Adjudicatory Team

- 1) Determine issues relating to simple disciplinary offenses committed by Judges and appointees of the Commission at zonal level and report same to the Secretariat of the Commission ;
- 2) Review the decision of the head Zonal Inspection Team and District courts Disciplinary Process Manager on appeal shall provide final decision;
- 3) Regulate the conduct of the zonal courts and ensure same.
- 4) Determine disciplinary issues relating to breach of disciplinary duties by the supportive staff at the zonal level in accordance with the pertinent civil service law.
- 5) Forward recommendations to the Supreme Commission with respect to promotion of judges and appointees of the Commission at zonal level in accordance with the existing rules and regulations;
- 6) Decide on transfer of judges and appointees of the Commission working in the districts under each zone in accordance with the existing regulations;
- 7) Evaluate the annual plan and budget of the courts in the zone and submit same to the Supreme Court;
- 8) Evaluate the reports of the courts in the zone and submit same to the Supreme Court;
- 9) Perform such other duties assigned to it by the Supreme Commission.

23. Powers and Duties of the Chairperson of the Zonal Adjudicatory Team

The chairperson of the Zonal Adjudicatory Team shall have the following powers and duties:-

- 1) Coordinate the activities of the Zonal Adjudicatory Team;

- 2) Walgahii Garee Gumichaa ni waama, ni gaggeessa;

24. Organization of the Zonal Inspection Team

The Zonal Inspection Team shall have a head, inspectors and the necessary supportive staffs to discharge its functions properly.

25. Powers and Duties of the Zonal Inspection Team

The Zonal Inspection Team shall have the following powers and duties:-

- 1) Receive complaints and grievances made on the service delivery of the;
- 2) Investigate the matter where it is convinced that there are evidences that show breach of discipline;
- 3) Frame charge, prosecute and take appeal upon being convinced that there is sufficient evidence for breach of discipline leading to prosecution;
- 4) Where it is convinced that there is no sufficient evidence to prosecute for breach of discipline based on its assessment of the complaints or the results of its investigation close the file and issue report on same to the chairperson of the Zonal Adjudicatory Team;
- 5) Organize awareness raising programs that aim at creating judicial community that does not tolerate unethical behavior and follow up implementation of same;

29. Oath

Judges shall take the following oath before assuming their duties:

I _____ up on my appointment as a judge of Oromia Courts, on this day, pledge to discharge with dedication and in accordance with the law the heavy responsibility entrusted to me.

30. Resignation

- 1) Judges or appointees of the Council shall have the right to resign from the responsibilities of their office upon their free will.
- 2) If they plan to resign in accordance with the circumstances indicated hereinabove, they shall be obliged to give prior notice of two months in writing to the President’s Office at the Supreme Court.
- 3) Notwithstanding resignation as indicated herein above a judge or appointee of the Council who resigned while disciplinary proceeding is pending against him shall not be entitled to get clearance until the disciplinary proceeding is finalized.

31. Removal of Judges from Office

No judge shall be removed from his duties except under the following conditions:-

- 1) Where he has attained the age of 60; or
- 2) Where it is decided by the Judicial Administration Council that he is incapable of discharging his duties on account of illness; or
- 3) When the Supreme Council decides that he is incompetent and inefficient to properly discharge his judicial duties in accordance with the performance appraisal regulations of judges and Appointees of the Council; or,
- 4) When it is decided that he shall be removed on account of violation of disciplinary rules.

32. Power to Issue Regulations and Directives

The Judicial Administration Council can issue different regulations and directives to implement the provisions of this Proclamation.

33. Term of Office of Members of Supreme Council and Adjudicatory Teams

- 1) The term of office of members of the Supreme Council and the members of the Adjudicatory Teams shall be three years.
- 2) Members of the Supreme Council and the Adjudicatory Teams may be re-elected for the second time.

34. Plenum of the Bodies of the Council

- 1) The plenum of the various bodies of the Judicial Administration Council shall be held biannually.
- 2) This plenum will evaluate the performance of the various organs of the Council and issue recommendations on how the prevailing gaps or problems could be addressed.

35. Pending Disciplinary Matters

All disciplinary matters pending before the coming into force of this Proclamation shall continue to be finalized in accordance with the previous law and procedures.

36. Repealed Laws

- 1) The Proclamation Issued to Consolidate the Powers of the Judicial Administration Council No. 54/2001 is hereby repealed by this Proclamation.
- 2) Any law, directive, decision and working procedure inconsistent with this Proclamation shall have no effect.

37. Effective Date

This Proclamation shall enter into force as of 19th day of July, 2008.
